**CERTIFICATION OF RESULTS**

Pursuant to an agreement with Dan Wills, Election Chair, of Transport Workers of America, AFL-CIO, Local 563, hereinafter referred to as "Local 563," the American Arbitration Association, hereinafter referred to as the "Administrator," agreed to conduct an Officer Election.

Five Hundred and Fifty-Nine (559) ballots were mailed to eligible voters, on Thursday, November 10, 2011. Ballots packets were mailed from the offices of the A.A.A., 1633 Broadway, New York, New York. During the course of the election an additional eight (8) duplicate packets issued at the request of Local 563. Local 563 provided the Administrator with a list of persons who were eligible to vote. To be counted, ballots had to be received by the Administrator no later than 9:00 A.M., Monday, December 5, 2011.

The Administrator received Three Hundred Twenty-Two (322) envelopes.

The counting of ballots took place at the offices of the Administrator at 225 N. Michigan Avenue, Suite 1840, Chicago, Illinois on Monday, December 5, 2011 in the presence of observers. Secrecy of the ballot was maintained at all times.


